The Releasor does HEREBY FULLY RELEASE AND FOREVER DISCHARGE LYONS CHARTERS, MARK LYONS FISHING CHARTERS, THEIR EMPLOYEES, MASTER AND CREW, AGENTS(HEREIN REFERRED TO AS RELEASEES), OF AND FROM ANY AND ALL ACTIONS, CAUSES OR RIGHT OF ACTION, SUITS, DAMAGES, JUDGEMENTS, EXECUTIONS, CLAIMS, AND DEMANDS WHATSOEVER, EITHER IN LAW, ADMIRALTY, OR EQUITY, BY REASON OF ANY MATTER, CAUSE WHATSOEVER, KNOWN OR UNKNOWN, ARISING FROM ANY ACCIDENT, INJURY, DEATH, PROPERTY DAMAGE or FINANCIAL LOSS WHATSOEVER, RELATED TO, RESULTING FROM, OR IN ANY WAY CONNECTED WITH, RELEASOR and THEIR PARTY, BEING A PASSENGERS, while Fishing, Cruising, Swimming, Working, Scuba Diving, Spearfishing or any activity whatsoever whether caused by the NEGLIGENCE OF RELEASEES or otherwise. Risks for consideration are but not limited to: sharp objects, allergies to fish or shellfish, slip hazards, dangerous aquatic animals, not having medical treatment readily available

This release contains the entire agreement between the parties hereto, shall not be altered, except in writing signed by both parties, and shall be considered a contractual agreement, and not a mere recital. RELEASOR FURTHER STATES THAT HE OR SHE HAS CAREFULLY READ THIS ENTIRE AGREEMENT AND SIGNED IT OF HIS OR HER OWN FREE WILL. RELEASOR HAS FULL KNOWLEDGE, ACCEPTANCE AND ASSUMPTION OF ANY AND ALL RISKS and assumption of risk for all members of their party aboard this vessel, including any minors accompanying them on MARK LYONS FISHING CHARTERS.

## Cancellation Policy

A deposit is required upon time of reservation. Deposit amounts vary. This deposit can be refunded up to fourteen days prior to the reservation date, for any reason. If there is less than 14 days prior to your reservation date the deposit is non-refundable. If for any reason the Captain or Lyons Charters cancels the trip your deposit will be refunded, this includes all weather related cancellations.

## Published Rates

Advertised published rates are “cash discount” rates. Our rates for trips are published on our website and are subject to change at any time. We do not charge fuel surcharges, mandatory tips, bait fees, equipment rentals or license fees. A card payment processing fee may apply.

## Card Payment Processing

The charge for card convenience is 3.5%. We do not charge a convenience fee on a deposit if the remaining balance is paid in cash, if the remaining balance is paid with credit or debit card the overall trip total, including the deposit, will be charged with a 3.5% increase fee at the time of the trip.

### **Driving Directions**

If your trip is on our 31ft offshore boat, Captain Mark will meet you at O'Neill's Marina in slip number 9 ( 6701 Sunshine Skyway Lane, St Petersburg, 33711 )

If your trip is on our 20ft inshore boat he will meet you at Maximo Park (End of Pinellas Point Dr, next door to O'Neill's Marina) follow the road way to the boat ramps

If you don't know which boat, it is very important to contact the captain immediately

#### **Coming From The Beaches**

Take Gulf Boulevard to 35th Ave/Pinellas Bayway #682. Follow the Pinellas Bayway to Interstate I-275 and US 19 exchange. Keep left following exit to US 19. Continue straight passing under I-275. At the next light turn right onto 31st street south. At 66th avenue south (Pinellas Point Drive) turn right. Follow Pinellas Point Drive under I-275 and the entrance to O'Neill's Marina is immediately on your left or Maximo is straight ahead.

#### **Coming From Sarasota - Bradenton**

Take I-275 North across the Skyway to Saint Petersburg. Take the first exit after the Skyway which is #16 Pinellas Point Drive- Skyway Lane. Turn left at the bottom of the ramp onto Skyway Lane. Turn left at Pinellas Point Drive. Pass under the interstate and turn left into O'Neill's Marina or Maximo Park is straight ahead.

#### **Coming from Tampa or Clearwater**

Take I-275 South to Saint Petersburg. Take exit #16 Pinellas Point Drive. Turn right then immediately left at the bottom of the ramp into the entrance of O'Neill's Marina or Maximo Park is straight ahead.
